3. Submit the Differential amount of **Nu 1,546,885.86 (ONE MILLION FIVE HUNDRED FORTY SIX THOUSAND EIGHT HUNDRED EIGHTY FIVE POINT EIGHT SIX) (4.19% of the contract price)** Only from the reputed Financial Institution acceptable to the procuring Agency in the form of unconditional bank guarantee valid till end of project completion
4. Submit the Differential amount for GSB, WMM and V-drain items, amounting to **Nu. 12,048,872.62 (TWELVE MILLION FORTY EIGHT THOUSAND EIGHT HUNDRED SEVENTY TWO POINT SIX TWO)** Only from the reputed Financial
