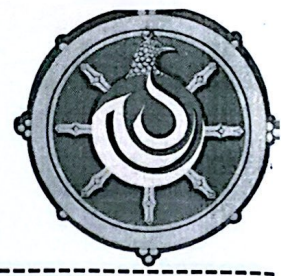
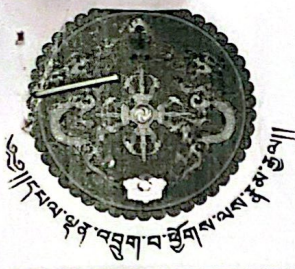

Invitation for Bids

Deadline for submission of Bids: 02:00 PM on 24th February, 2026 (Bhutan Standard Time)

1. The Kingdom of Bhutan has received financing from the Asian Development Bank (ADB) towards the cost of the **Water Flagship Program Support Project**. Part of this financing will be used for payments under the contracts named above. Bidding is open to Bidders from **eligible source countries of the ADB**. However, a successful bidder (International) is required to register with the Bhutan Construction and Transport Authority (BCTA) before award of the contract.
2. The **Wangduephodrang District Administration**, ("the Employer") invites sealed bids from eligible Bidders for the Construction of Integrated Drinking Water and Irrigation Scheme, Hesotshamchu Transmission Line and SCADA including O&M for 2 years ("the Work").
3. Open Competitive Bidding (OCB-International) will be conducted in accordance with ADB's Single-Stage: One-Envelope Bidding Procedure and is open to all Bidders from eligible countries as described in the Bidding Document.
4. Eligible bidders with the following key qualifications should participate in this bidding:
 - a) **Construction Experience Requirement:** Participation as a contractor, Joint Venture Partner, or Sub-Contractor in **at least one** contract that have been successfully or substantially (95%) completed within the last 7 years: (**January 2019 to December 2025**) and that is similar to the proposed works, where the value of the Bidder's participation in the contract exceeds **BTN 375 million**.
 - b) **Financial requirement:** Minimum Average Annual Construction Turnover (AACT) of **BTN 562 million**, calculated as total certified payments received for contracts in progress or completed within last 5 years (i.e. 2020, 2021, 2022, 2023 and 2024)
 - c) Meet other financial and experience requirements as indicated in the Bidding Document.

However, for complete eligibility and qualification requirements, interested bidders should refer to the Bidding Documents.


